Dear Ms. Leyden:

Thank you for your October 18, 2005, request to incorporate numerous changes to the Maine Coastal Program based on public laws enacted by the 122nd Maine Legislature during its First Regular and First Special Sessions, from December 1, 2004, to June 18, 2005; public laws enacted by the 121st Maine Legislature in connection with the recodification of Title 12 of the Maine Revised Statutes Annotated; and amendments to the permit-by-rule regulations administered by the Maine Department of Environmental Protection. You specifically requested that these revised statutes and regulations be incorporated into the Maine Coastal Program (MCP) as routine program changes (RPC's) per the Coastal Zone Management Act (CZMA) regulations at 15 C.F.R. § 923.84. OCRM received the request on October 28, 2005.

Based on our review of your submission, the Office of Ocean and Coastal Resource Management (OCRM) concurs that the changes to the statutory and regulatory provisions noted below are RPC's and OCRM approves the incorporation of the statutory and regulatory provisions as enforceable policies of the Maine Coastal Program (MCP).
